Fabio represents private and public clients in a wide variety of disputes arising from the Clean Water Act (CWA), Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA), Washington’s Model Toxics Control Act (MTCA), breach of contract, and business and environmental torts.

Fabio also advises on environmental and natural resources matters, including regulatory issues related to the CWA, National Environmental Policy Act (NEPA), Resource Conservation and Recovery Act (RCRA), Toxic Substances Control Act (TSCA), and tribal law. Fabio has broad experience with per- and polyfluoroalkyl substances (PFAS) and other emerging contaminants.
