Brianna Morrison focuses her practice on representing creditors across a range of commercial and bankruptcy matters. Her work includes creditor-side representation in collection actions, enforcement and collection of judgments, claim and delivery proceedings, and complex bankruptcy litigation.

Brianna has developed particular depth in Chapter 11 agricultural bankruptcies, where she represents lenders and creditors navigating the intersection of farm operations, secured lending, and reorganization. She also handles fraudulent transfer litigation in bankruptcy court. Brianna brings firsthand experience from her time in South Carolina, where she represented Chapter 7 trustees in avoidance actions, including preferential and fraudulent transfers under the Statute of Elizabeth.
