We are proud to share Miller Nash LLP's first Annual Pro Bono Report, a reflection of our firm's deep and sustained commitment to advancing access to justice and serving our communities through pro bono service. That commitment is embodied in the legacy of our former partner Clifford N. Carlsen, Jr., whose leadership and dedication to civil rights and public service continue to inspire our work today. Rooted in 150 years of firm history, this report celebrates the service of our attorneys and professional staff, showcasing not only the hours contributed toward pro bono service but also the meaningful outcomes achieved for individuals, families, and nonprofit organizations across Oregon, Washington, California, Idaho, and Alaska. From direct representation in domestic violence hearings and civil rights matters to supporting nonprofit missions and legal aid clinics, our pro bono efforts continue to uphold a core pillar of our firm's vision—our community.

Miller Nash attorneys and paralegals across our offices collectively contributed **4,184 pro bono hours** in 2025, an increase from 2,763 hours in 2024 and 2,460 hours in 2023, representing the equivalent of **\$2.2 million in legal services**. In 2025, **more than 95 timekeepers participated in pro bono matters**, underscoring the breadth of engagement across practices, offices, and experience levels.

The accomplishments and matters highlighted in this year's annual report provide a snapshot of the diversity and depth of our pro bono program. Miller Nash lawyers and staff secured the safe return of an abducted child under the Hague Convention, represented survivors of domestic violence and children in high-conflict custody matters, provided governance and transactional support to mission-driven nonprofit organizations, expanded immigration advocacy for vulnerable individuals and families, and accepted court appointments in complex federal civil rights cases—including a single matter in which a trial team devoted more than 600 hours to ensure a pro se litigant had meaningful access to justice and an opportunity to share his story with a jury. These efforts reflect not only the skill and dedication of our attorneys, but also a firmwide commitment to using our legal experience to make a tangible difference in the communities we serve. We are proud of what our lawyers and staff accomplished together this year, and we look forward to continuing and expanding this work in the years ahead.

DEFENDING CONSTITUTIONAL RIGHTS THROUGH U.S. DISTRICT COURT-APPOINTED PRO BONO PROGRAMS

Miller Nash actively participates in the representation of pro se litigants in civil rights cases through the U.S. District Court of Oregon's and Western District of Washington's pro bono programs. The programs offer legal representation for individuals who do not have the means to obtain counsel on their own and offer Miller Nash lawyers the opportunity to gain meaningful experience advocating in federal court, including at oral argument and trial.

DEFENDING CONSTITUTIONAL RIGHTS THROUGH U.S. DISTRICT COURT-APPOINTED PRO BONO PROGRAMS

Miller Nash accepted appointments in the following cases:

Al-Khafagi v. Crites et al.

Judge Adrienne Nelson appointed Heather Van Meter and Sophia von Bergen to represent a pro se litigant alleging Eighth Amendment claims relating to his medical treatment while in custody with the Oregon Department of Corrections.

Fennell v. Jackson County.

Judge Marco Hernández appointed John Clarke and Katie Bennett to represent a pro se litigant seeking to remedy harm allegedly suffered in Jackson County Jail.

Rodriguez v. Amsberry et al.

Judge Karin Immergut appointed Mark Tyler to represent a pro se litigant pursuing a claim for excessive force in violation of the Eighth Amendment. Tyler represented this litigant through a jury trial.

Yassin v. Gonzalez.

Judge Russo appointed John Clarke and Adrian Anderson to represent a pro se litigant for the limited purpose of assisting with effecting service of process on the defendant.

Bynum v. Morrissey O'Donnell et al.

Judge Jeffrey Armistead appointed Edward Decker and Abigail Yeo to represent a pro se litigant seeking to protect his ability to exercise his religious freedom while incarcerated at Multnomah County Detention Center.

King v. King.

Judge Ann Aiken appointed Ian Christy and Sophia von Bergen to represent a pro se litigant alleging a failure to protect violation under the Eighth Amendment. Christy and von Bergen resolved this matter for the client through a mediation.

Rodriguez v. Anderson et al.

Judge Karin Immergut appointed Michael Porter, April Fredrickson, and Jessica Bernardini to represent a pro se litigant pursuing a claim for excessive force in violation of the Eighth Amendment. Porter, Fredrickson, and Bernardini represented plaintiff through a jury trial.

Yassin v. Smith et al.

Judge Russo appointed John Clarke, Sophia von Bergen, and Adrian Anderson to represent a pro se litigant alleging violations of the Eighth Amendment arising from deliberate indifference to serious medical needs.



PROTECTING FAMILIES IN INTERNATIONAL PARENTAL ABDUCTION CASES

At Miller Nash, our international practice is built on a foundation of technical excellence, cultural fluency, and real-world experience, which the firm has been able to leverage to serve individual pro bono clients on cross-border legal matters.

In 2025, Miller Nash accepted a pro bono matter through the Hague Convention Attorney Network, representing a father whose two-year-old child was wrongfully abducted from the United Kingdom and brought to the United States by the child's mother. The case arose under the Convention on the Civil Aspects of International Child Abduction and the International Child Abduction Remedies Act, requiring the firm to establish the child's habitual residence, the father's custody rights under U.K. law, and the wrongful nature of the child's removal.

The Miller Nash team moved quickly, filing a Hague Petition and assembling critical evidence, including consular records, travel documents, communications, and personal testimony. The firm strategically pursued mediation in advance of trial and, through persistence and advocacy, secured the voluntary return of the child under all proposed conditions. Led by **Jakini Ingram** and **Dino Vasquez**, with support from **Semee Yim** and summer associates **Vivian Hernández** and **Eunhye Fay**, the Miller Nash team ensured the child's safe return to the United Kingdom on August 14, 2025.

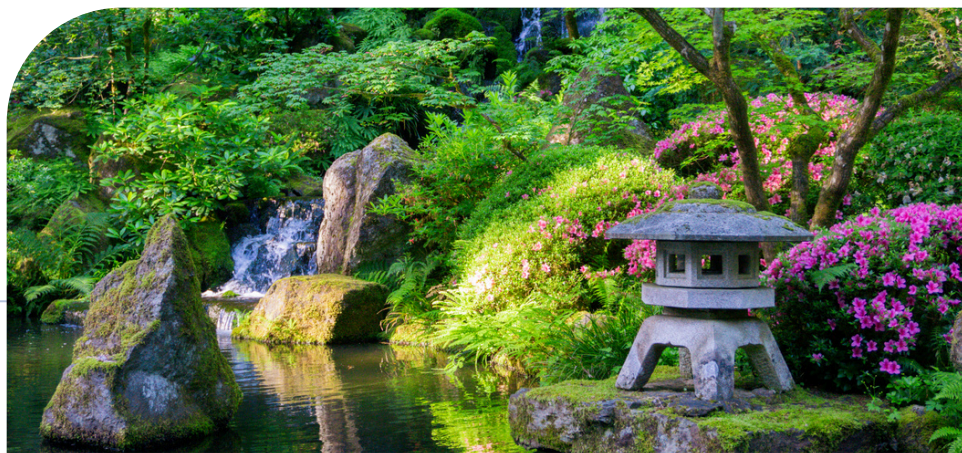

ADVISING SMALL BUSINESSES AND NONPROFITS

This year, Miller Nash attorneys **Eric Robertson**, **Andrea Moore**, and **Incainti Sofia McDonald** provided critical legal assistance to Portland Japanese Garden, a nonprofit organization dedicated to promoting peace, cultural understanding, and community healing. Founded in the aftermath of World War II to foster reconciliation with Japan and the Japanese American community, Portland Japanese Garden relies on philanthropic support to fund a portion of its operations. The Miller Nash team assisted the organization by updating its corporate governance documents, including its bylaws, helping ensure that the Garden's legal framework continues to support its mission and long-term sustainability.

The Miller Nash team collaborated closely with Garden leadership, responded promptly to client inquiries, and completed the work on an expedited timeline. Following completion of the project, Kathy Parmenter, Director of Board Relations for Portland Japanese Garden, personally thanked the team, noting that their efforts were critically important to the organization and expressing deep appreciation for their professionalism and responsiveness. The engagement exemplifies how Miller Nash's legal skills can meaningfully strengthen community institutions and advance the firm's commitment to pro bono service.





SUPPORTING DOMESTIC VIOLENCE AND CHILDREN'S REPRESENTATION PROJECTS

Through Legal Aid Services of Oregon's (LASO) Domestic Violence Project, Miller Nash lawyers, led by **Radhika Shah**, have matched with survivors of domestic violence for representation in contested restraining order hearings—a highly impactful pro bono opportunity providing legal advocacy for clients navigating emotional and critical safety proceedings. The project focuses on contested hearings in Clackamas, Multnomah, and Washington Counties and offers an accessible opportunity for Miller Nash attorneys to contribute pro bono counsel to survivors who might otherwise proceed without the benefit of counsel.

After a hearing this year, Radhika's client wrote: "Hi Radhika, I just wanted to thank you again for representing me at the hearing pro bono. I'd been told that this was the type of hearing you can do without a lawyer, but there's no way I could have gotten through it without your help and guidance."

In 2025, Radhika was also invited by a Multnomah County judge to join the Children's Representation Project, a court-appointed initiative in which attorneys represent children in contentious family law matters. Recognizing the profound need in this area, Radhika accepted and has since represented children in two challenging family law matters where the parents could not agree on custody or parenting time. Over eight months, she devoted nearly 90 hours to these cases, developing a keen understanding of her clients' needs and desires and ensuring that their voices were meaningfully heard in court.

Through these efforts, Miller Nash and Radhika have demonstrated a sustained commitment to increasing access to justice for survivors of abuse and for children in high-conflict legal situations, embodying the firm's pro bono values and deep engagement with community legal needs.

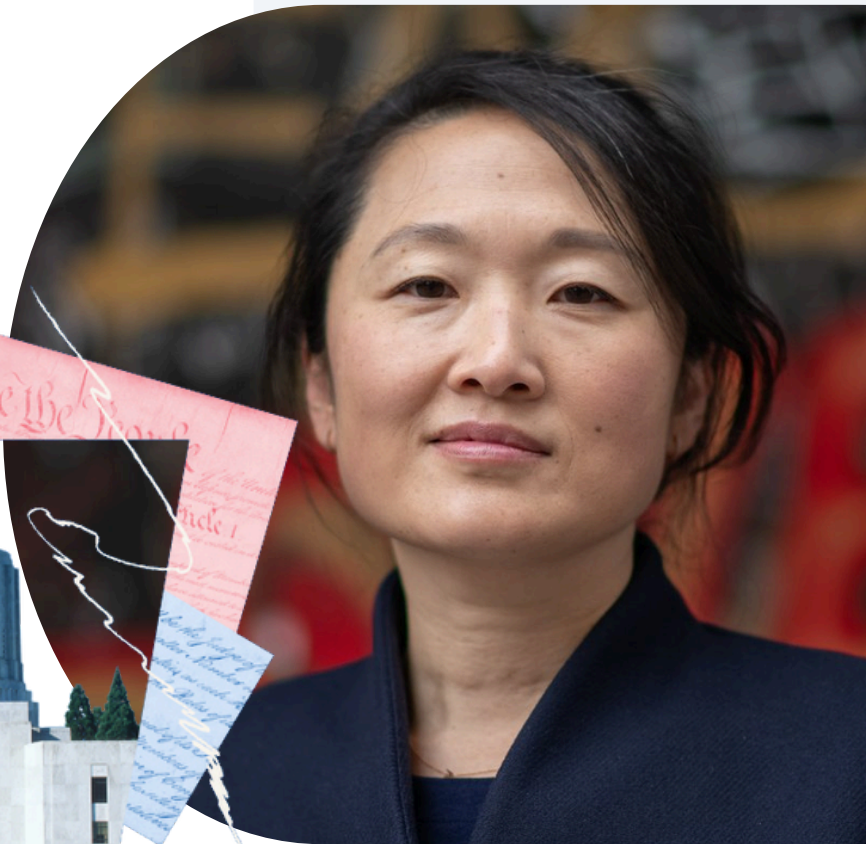

INTERVIEW WITH ACLU OF OREGON



Sandy Chung serves as the Executive Director of ACLU of Oregon, leading the organization’s efforts to defend and advance civil rights and liberties across Oregon communities. The ACLU of Oregon is a nonpartisan membership organization. The organization works in the courts, in the legislature, and in communities to defend and advance the individual rights and liberties that the Constitution and the laws of the United States guarantee everyone in this country. Miller Nash lawyers have supported the ACLU of Oregon’s mission for decades, partnering with the organization on impact litigation and investigations and serving on its lawyers’ committee and board of directors. Chung is the fifth executive director, and first attorney, to lead the 65-year-old organization.



INTERVIEW WITH ACLU OF OREGON

What inspires you to serve as ACLU of Oregon's executive director?

I am inspired by the ACLU of Oregon's vision of fulfilling our country's promise to be a democracy that is truly of, by, and for all the people—where all people and communities have fundamental freedoms and rights, access and power to engage fully in our democratic processes, and inherent value, dignity, and autonomy.

What has been the most meaningful aspect of being the executive director for ACLU of Oregon?

It has been particularly meaningful to me to share my family's immigration and democracy story, especially during the current times.

My family and I emigrated from South Korea to the US in the early 1980s when I was five years old. At that time, South Korea was ruled by a military dictator, and in 1980, the government suppressed pro-democracy protests in a city called Kwangju by killing several hundred to several thousand protestors, including many university students. Kwangju is my dad's hometown, and my parents decided to emigrate because they were profoundly disillusioned with their country. However, even in the face of such repression and violence, the people in South Korea were able to build a strong democracy over time and were also able to defend their country against recent authoritarian attacks.

I share my family's story because I think it is important for us to remember that people across the world and through history have struggled for freedom and liberation, and there are always ways for each of us to defend and advance our democratic values.

How have ACLU of Oregon's needs for pro bono counsel evolved in recent years?

During most of the organization's history, we did not have a legal staff team and most of our legal work historically was done by pro bono counsel.

Currently, we have a wonderful legal team led by our Legal Director Kelly Simon and supported by Eri Andriola, Litigation Manager, and Lisa Kwon, Legal Associate. We are also currently recruiting for a second Litigation Manager and welcome applications from attorneys with at least five years of civil litigation experience.

Although our legal team leads and coordinates our legal work, we continue to collaborate significantly with the pro bono legal community across our state to protect and advance the civil liberties and civil rights of Oregonians.

What do you see as the ACLU of Oregon's key pro bono needs in 2026?

During 2025, the ACLU engaged in more than 200 legal actions, including filing over 110 lawsuits. In more than 70 percent of our cases, we successfully defeated, diluted, or delayed unconstitutional actions by the government. Many of these cases involved complex civil and constitutional litigation, at times representing class plaintiffs. We anticipate that we will continue to need pro bono legal support with similar types of cases during 2026, oftentimes involving issues of basic constitutional rights.

What is your message to attorneys who want to support the ACLU of Oregon's mission in 2026?

The continuing health, resilience, and strength of our democratic institutions depends on each of us doing our part, and as the guardians of the rule of law and the Constitution, attorneys are particularly essential to our democracy.
